ARTICLES OF INCORPORATION

THE UNDERSIGNED, acting as incorporator of a corporation under the Florida Business Corporation Act, F.S. Chapter 607, adopts the following Articles of Incorporation for such corporation:

## ARTICLE I - Name and Address

The name of this Corporation is: RICHARD GOLDBERG, M.D., D.O., P.A. and the principal place of business and mailing address of this Corporation shall be 1688 South Club Drive, Wellington, FL 33414.

## ARTICLE II - Commencement and Duration

This Corporation shall commence on the date of filing of these Articles and the duration of this Corporation is perpetual.

### ARTICLE III - Purpose

This Corporation is organized for the purpose of conducting a licensed medical clinic.

#### ARTICLE IV - Stock

# Common Directors - Transactions Between Corporations

No contract or other transaction between this Corporation and one or more of its Directors or any other corporation, firm, association or entity in which one or more of its Directors are directors or officers or are financially interested, shall either be void or voidable because of such relationship or interest, if:

(a) the fact such relationship or interest is disclosed or known to the Board of Directors or committee which authorizes, approves or ratifies the contractor transaction by vote or consent sufficient for the purpose without counting the votes or consents of such interested Director; or (b) the fact of such relationship or interest is disclosed or known to the Shareholders entitled to vote and they authorize, approve or ratify such contract or transaction by vote or written consent; or (c) the contract is fair and reasonable to the Corporation.
