ARTICLES OF INCORPORATION

OF

The undersigned incorporators hereby make, subscribe to, acknowledge and file these Articles of Incorporation for the purpose of organizing and incorporating a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is:

ARTICLE II

The general nature of the business to be transacted by this corporation is as follows:

- A. To engage in the business of real estate investments and various other ventures; and to exercise generally such powers as may be incidental to or convenient for the purposes and business of this corporation.
- B. To have, exercise and enjoy all of the rights and privileges of corporations for profit as conferred by the laws of the State of Florida, it being expressly provided that the enumeration of specific powers and purposes shall not be held to limit or restrict in any manner the business of the corporation.

ARTICLE III

Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock. Each share shall have a par value of \$.01 per share.

Term of Existence

This corporation is to exist perpetually.
