ARTICLES OF INCORPORATION

The undersigned, for purposes of forming a corporation under the Florida General Corporation Act, does hereby <sup>SECRETARY OF STATE
TALLAHASSEE, FLORIDA</sup> adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is MINH CORPORATION.

ARTICLE TWO

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE THREE

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock, having a par value of \$1.00 per share.

ARTICLE FOUR

The corporation shall have perpetual existence, commencing immediately upon the filing of these Articles of Incorporation with the Secretary of State.

ARTICLE FIVE

The Registered Agent and street address of the initial Registered Office of this corporation in the State of Florida shall be:
