**ARTICLES OF INCORPORATION  
OF  
DIGITAL EQUIS MIAMI CORP**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of this corporation shall be: Digital Equis Miami Corp.

**ARTICLE II - PURPOSE**
