The aggregate number of shares which the corporation shall have authority to issue is **100**, at **\$1.00** par value.


ARTICLE FIVE

ARTICLE EIGHT


The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
