# ARTICLES OF INCORPORATION

OF

#### ARTICLE 1.

Name and Mailing Address. The name of this corporation is KEN ANDERSON HOMES, INC. and its mailing address is 1023 Willa Lake Cr., Oviedo, FL 32765.
