OF  
WORLD-WIDE SOURCING CORP.**

**Article 1 - NAME**

The name of this corporation is **WORLD-WIDE SOURCING CORP.**

**Article 2 - DURATION**

This corporation shall have perpetual existence.

**Article 3 - PURPOSE**
