**ARTICLES OF INCORPORATION
OF
HATCHER, INC.**

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following articles of incorporation for such corporation:

**ARTICLE I
Name**

The name of the corporation is Hatcher, Inc.

**ARTICLE II
Initial Principal Office and Mailing Address**

The Corporation's initial principal office and mailing address is 3325 Bayshore Boulevard, Unit B-36, Tampa, Florida 33629.

**ARTICLE III
Shares**

The corporation shall have authority to issue 2,100 common shares with a par value of \$1.00 per share, which shall be divided into two series:

1. Series A common shares, of which 100 shares will be authorized, each of which shall entitle the holder thereof to one (1) vote at any meeting of the shareholders; and
2. Series B common shares, of which 2,000 shares shall be authorized, which shall have all the rights and privileges of the Series A common shares except that the holders thereof shall not have the right to vote.
