ARTICLE ONE

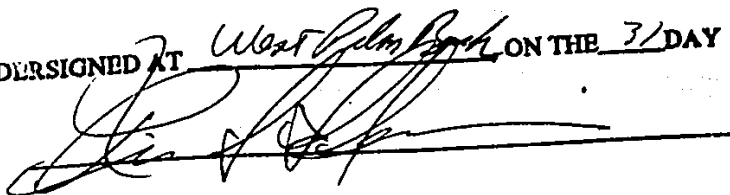
