





BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

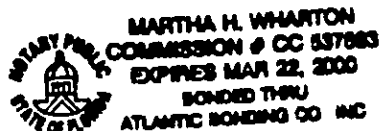
1. NAME. The name of this corporation is Soho Connection, Inc.
6515 Bay Street, St. Petersburg Beach, FL 33706
2. TERM. This corporation shall exist perpetually.
3. PURPOSE. The purpose of this corporation is to transact any or all lawful businesses for which corporations may be incorporated under Chapter 607 Florida Statutes.
4. CAPITAL STOCK. The maximum number of shares of stock which the corporation is authorized to have outstanding at any time shall be 50,000,000 shares of common stock having a par value of \$.00001.


