ARTICLES OF INCORPORATION  
OF

FLORIDA STATE ROLL RUNNERS, INC.

The undersigned incorporator makes, subscribes, acknowledges and files with the Department of State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is ~~FLORIDA STATE ROLL RUNNERS, INC.~~

ARTICLE II

TERMS OF EXISTENCE

This corporation shall commence as of the date of filing of these Articles of Incorporation with the Secretary of State and shall have perpetual existence.

ARTICLE III

NATURE OF BUSINESS

This corporation may engage in any lawful act or activity for which authorized corporations may be organized under the laws of the United States of America and of this State.

ARTICLE IV

CAPITAL STRUCTURE

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock, having a par value of \$1.00 per share. Each of the said shares shall entitle the stockholder thereof to one (1) vote at any meeting of the stockholders. All or any part of said capital stock may be paid for in cash, in property or in labor and services at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be paid for and shall be non-assessable.

## INITIAL REGISTERED AGENT AND REGISTERED OFFICE

The Board of Directors from time to time may move the registered office to any other address in the State of Florida. The principal address of the office is 3936 Hwy 77, CHIPLEY, FLORIDA

## ARTICLE VI

## BOARD OF DIRECTORS

There shall be a Board of Directors for this corporation which shall consist of not less than one (1). Except for the number constituting the initial Board of Directors, the number of Directors shall be decided by resolution of the stockholders.

## ARTICLE VII

## INITIAL BOARD OF DIRECTORS

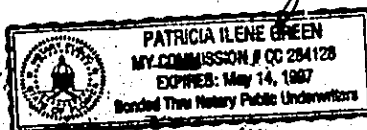
