ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of SECRETARY OF STATE TALLAHASSEE, FLORIDA Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be LINCOLNVILLE CENTER ACADEMY, INC. The principal place of business of this corporation shall be 54 Weeden Street, St. Augustine, Florida 32084.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock having a par value of \$1 per share.

The corporation is authorized to issue only one class of stock and all issued stock shall be held of record by not more than five persons. The stock shall be issued and transferable only to natural persons who are not nonresident aliens.

ARTICLE IV. STOCK TRANSFER RESTRICTION

No stockholder shall have the right to sell, assign,

pledge, encumber, transfer or otherwise dispose of any shares of the corporation without first offering such stock to the corporation for a sale price based upon the net asset value of the Corporation. Such offer shall be in writing, signed by the stockholder, and shall be sent by registered or certified mail to the corporation at its principal place of business and shall state that the offer shall remain open for acceptance by the corporation for a period of 14 days from the date of mailing. If the corporation fails or refuses within that period to make reasonably satisfactory arrangements for the purchase of such shares, the shareholder shall have the right to dispose of his shares as he may see fit.

On the death of any stockholder, the corporation shall have the right to purchase all shares owned by such shareholder immediately prior to his death on the terms set forth above, and this provision shall be binding on the executor, administrator or personal representative of each stockholder, who shall be obligated to make the written offer set forth above. Each share certificate issued by the corporation shall have printed or stamped thereon the following legend:

"These shares are not registered under either Federal or Florida law, and are held subject to certain transfer restrictions imposed by the Articles of Incorporation. A copy of such Articles is on file at the principal office of the corporation and is open to inspection upon reasonable notice."

ARTICLE V. ADDRESS

The street address of the initial registered office of the

corporation shall be 54 Weeden Street, St. Augustine, Florida 32084, and the name of the initial registered agent of the corporation at that address is Judith Anne Sharpe.

ARTICLE VI. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VII. DIRECTORS
