ARTICLE I: NAME

The name of the corporation shall be PACIFIC COMMUNICATION GROUP, INC. The address of the principal office of this corporation shall be 7697 Greenboro Drive, West Melbourne, FL 32904, and the mailing address of the corporation shall be the same.

ARTICLE II: NATURE OF BUSINESS AND PURPOSE

This corporation shall engage in manufacturing, sales, import and export of satellite communication products, computer products, telecommunication equipment, wireless communication instruments and equipment, machinery equipment, medical equipment, construction materials, chemical manufacturing equipment, general international trade, and may engage in or transact any and all lawful business or activities permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.
