ARTICLE I - NAME

The name of this Corporation is B & A TRANSPORTATION, INC.

This Corporation shall have perpetual existence commencing
on October 31, 1996.



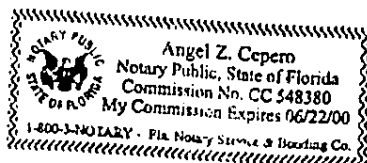
