The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be **WEST COAST YACHT SERVICES, INC.** The principal place of business of this corporation shall be 1320 11th Court North, Naples, Florida 34102.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III - CAPITAL STOCK

Bylaws but shall never be less than one (1). The name and address of the initial director of the Corporation is as follows:





