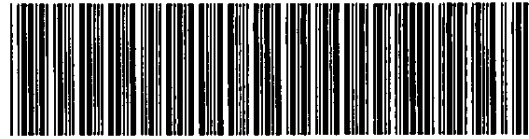



Pursuant to the provisions of Section 607.1006, Florida Statutes, this professional Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Amendment adopted:

Article I, NAME OF CORPORATION, is amended to read as follows:

The name of this Corporation shall be "CARNEY & ASSOCIATE, P.A." The Corporation shall be referred to in this instrument as the "Corporation"; these Articles of Incorporation shall be referred to as "Articles"; and the Bylaws of the Corporation shall be referred to as "Bylaws".

SECOND: The above referenced amendment is adopted as of the date of execution of this document and shall take effect on May 1, 2013.

THIRD: The Amendment was adopted by the Board of Directors without shareholder action and shareholder action was not required.
