The undersigned, acting as incorporators of a corporation for profit under the Florida Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is: CANARDIERE CO., INC.

ARTICLE II

The corporation shall have perpetual duration.

ARTICLE III

The corporation is a for profit corporation. The general purpose for which this corporation is formed is to purchase and own land for resale for the Thomas A. Hoadley, P.A.
