

## ARTICLES OF INCORPORATION

OF

The undersigned subscriber(s) to these Articles of Incorporation, competent to contract, hereby form a corporation under the laws of the State of Florida.

## ARTICLE I. NAME

The name of the corporation is: SUNCO SALES, INC.

## ARTICLE II. PURPOSES AND POWERS
