The undersigned subscriber (s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

# ARTICLE 1. - NAME

The name of this corporation is:

PAK MAIL OF JACARANDA, INC.

# ARTICLE 11. - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

- (a) To engage in all aspects of handling & preparation of all types of mail & packages for delivery or pickup to or hy the postal service, airlines, federal express, UPS, etc., to provide for public use of equipment at a fee, to sell mail accessories and to engage in any and all other functions, services, and/or activities considered necessary, incidental, proper and/or ancillary, thereto, and to do all other things which may be desirable to achieve the purposes aforesaid and to operate a successful business.
