ARTICLE I - NAME

The name of this corporation is SOMMERTRAUM, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

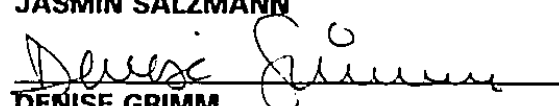
