## ARTICLES OF INCORPORATION

OF

#### **PEGASUS-FIVE CAPITAL CORPORATION**



#### ARTICLE 1

#### NAME OF CORPORATION

The name of this corporation is PEGASUS-FIVE CAPITAL CORPORATION.

#### **ARTICLE 2**

#### CORPORATE EXISTENCE

This corporation shall have perpetual existence unless sooner dissolved according to law. The address of the principal office of the corporation is 3200 Commonwealth Boulevard, Tallahassee, Florida 32303.

#### ARTICLE 3

#### **PURPOSE OF BUSINESS**

The purpose of this corporation is to engage in the transaction of any or all lawful business.

#### ARTICLE 4
