The undersigned, incorporator to these Articles of Incorporation hereby forms a corporation under Chapter 621 of the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation shall be:

ARTICLE II

NATURE OF BUSINESS

This corporation may engage in every aspect of the business of rendering the service of maintenance, repair and servicing of swimming pools and swimming pool decks to the public, and this corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory, or nation.
