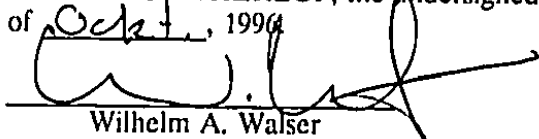
#### ARTICLE VII. INCORPORATOR

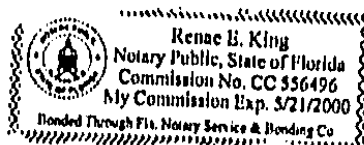
