ARTICLES OF INCORPORATION
of

Article I -- Name

The name of this corporation is DELRAY COIN LAUNDRY, INC.

Article II -- Duration

This corporation shall exist for a perpetual period of time.

Article III -- Purpose

This corporation is organized for the purpose of to operate a laundry business, and transacting any and all business which may be permitted under the laws of the State of Florida, and approved by the Board of Directors.

Article IV -- Capital Stock




