The undersigned, acting as incorporator of Natural Vitality, Inc., under the Florida General Corporation Act, adopts the following Articles of Incorporation:

## ARTICLE I - NAME

The name of this corporation is Natural Vitality, Inc., and the mailing address of this Corporation is 5901 SW 94th Street, Miami, Florida 33156.

# **ARTICLE II - COMMENCEMENT OF EXISTENCE**

This corporation shall commence on the date on which these Articles of Incorporation are filed with the Secretary of State.

## ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

#### ARTICLE IV - AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1,000 shares of common stock, having a par value of \$1.00 per share. The Board of Directors shall fix the consideration to be received for each share. Such consideration shall consist of any tangible or intangible property or benefit to this corporation, including each, promissory notes, services performed or written promises to perform services and shall have a value in the judgment of the directors, equivalent to or greater than the full par value of the shares.

#### **ARTICLE X - AMENDMENT**

This corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, in the manner prescribed by law, and all rights conferred on shareholders are subject to this reservation. These Articles may be amended prior to the issuance of shares of the corporation by the unanimous approval or consent of the board of directors. Thereafter, every amendment shall be approved by the board of directors, proposed by them to the shareholders, and approved at a

shareholders' meeting by the holders of a majority of the shares entitled to vote on the matter or in such other manner as may be provided by law.
