THE UNDERSIGNED subscriber to these articles of incorporation, being duly licensed to practice veterinary medicine under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Corporation Act, F.S. Chapter 621, and other law of the State of Florida.

ARTICLE ONE. NAME

The name of the professional service corporation is Deborah Buckner, P.A.
