

ARTICLE I. CORPORATE NAME

The name of this corporation is BOCA INTERNATIONAL SYMPOSIUM, INC., (hereinafter called the "Corporation")

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation are 1515 N. Federal Hwy., Suite #300, Boca Raton, Florida 32825.

ARTICLE III. CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares, par value of per share.

Shares of capital stock of the corporation that have been issued and subsequently acquired by the Corporation shall constitute issued but not outstanding shares of the same class and series, until canceled or disposed of (whether by resale or otherwise) by the Corporation. This corporation may be a Sub-Chapter S corporation as defined by the Internal Revenue Code.


ARTICLE IX AMENDMENTS


Designation and Acceptance of Registered Agent
