ARTICLES OF INCORPORATION OF HOFFCO INTERNATIONAL, INC.

PALLAMANNER 16

The undersigned hereby adopts the following Articles of to incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I

The name of the corporation is HOFFCO INTERNATIONAL, INC.

ARTICLE II

The corporation is to commence its existence on the date of filing and acknowledgement of these Articles of Incorporation and shall exist perpetually thereafter until dissolved according to law.
