2. The foregoing dissolution was authorized by the Shareholders and Directors of the Company by joint written consent as of the 27<sup>th</sup> day of July, 1998.

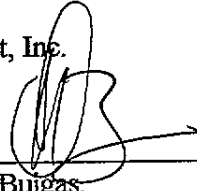
3. The number of votes cast for dissolution by the Shareholders was sufficient for approval of the action authorizing such dissolution.
