AUTICLES OF INCORPORATION

OF

The undersigned subscribers to these Articles of Incorporation, each a natural person, domestic or foreign corporation, partner of the ship, limited partnership or association, competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

ARTICLE I. - NAME

The name under which this corporation will conduct its business and be known and recognized is:
