The undersigned, as subscriber to these Articles of Incorporation, does hereby propose to effect a corporation under the laws of the State of Florida, and pursuant to Chapter 607 of the Florida Statutes.

ARTICLE I: Name: The name of the corporation is DDS OF PONTE VEDRA, INC.

ARTICLE II: Duration: The corporation shall have perpetual existence commencing on the date of filing of these Articles.

ARTICLE III: Purpose: This corporation is organized for the purpose of acquiring, renovating and renting or selling single family residence, and to do all and every thing necessary and proper for the accomplishment of the objects enumerated in its certificate of incorporation or necessary or incident to the benefit and protection of the corporation, and to transact any lawful business and to exercise all powers granted to corporations by the State of Florida.

ARTICLE IV: Capital Stock: The total authorized capital stock of this corporation is 500 shares, all of which shall be the par value of \$1.00 per share.

or services at a just valuation thereof to be fixed by the Board of Directors of this corporation at their first meeting or at a meeting called for that purpose.


ARTICLE IX: Indemnification. The corporation shall indemnify any officer or director, or any former officer or director, to the fullest extent permitted by law.




