To Whom It May Concern;

After contacting your office on 04 November 1997, and speaking with one of your representatives regarding the NOTICE OF ADMINISTRATIVE DISSOLUTION OR REVOCATION of our corporation RAJA Incorporated, we are writing this letter to explain to you the reasons that we had not responded to any previous notices or correspondence from your department and why we did not file an annual report with your department.

Insofar as our failure to respond to any previous communication from you, this was not due to any intended negligence or non-conformance on our part, but rather due to an error on the part of others with respect to our corporate mailing address. Our correct corporate mailing address is now and has been since the inception of our corporation, P.O. Box 6506, Delray Beach, FL., 33484. This correct address of P.O. Box 6506 was presumably mis-read by the person addressing your correspondence to us as P.O. Box 6500, which was an incorrect address. This error may have been caused primarily by a typographical error on the part of our attorney, who filed who filed our corporate applications (who also failed to file our FEDERAL EMPLOYEE IDENTIFICATION NUMBER of 65-0709776 with that application, which she had at that time in her possession, but which failure we have corrected on the attached form.) Consequently, all communications from your department were sent to an incorrect address. Further complicating this mixup, it is supposed that the P.O. boxholder of 6500, not having any connection to RAJA Inc., trashed any previous correspondence rather than return them to a Postal employee, as would have been proper.

The one and only correspondence or communication that we have received from your department is that to which we are concerned and addressing. I attribute this sole receipt only to an alert Postal employee who upon seeing the name and address of this correspondence and realizing the error, placed it in the correct P.O. box of 6506.

My wife and I sole partners in this corporation, are both retired living on a fixed income, and are in a small flea market business in order to supplement this meager income. Having been in business for only a year we relied heavily on our attorney, Ms. Carolyn S. Franks to guide us through and advise us in any corporate situations. This trust was obviously misplaced as Ms. Franks, who filed our applications and had all of our personal information, corporate papers, ledgers and stamp in her possession has since, with no notice to clients, has since left this area with no forwarding (I presume) address.

Not knowing of this or of any date to file an annual report, my wife and I wrongfully supposed that an annual report would be filed at the end of a corporation's business year, which for us, we assumed, would be 12 November 1997 and receiving no word to the contrary from our attorney who would "take care of everything", my wife and

I continued in this supposition since our attorney had failed to contact us and had not informed us of this or for that matter, any other corporate regulation.

It has, since contact with your representative , been explained to us by her that it is not the responsibility of an attorney to file this annual report or to notify clients of it's impending date.

In defense of this omission we can only state that this breach was due to our misplaced trust, lack of information concerning Florida Department Of State , Division Of Corporations regulations, and our own naive ignorance.

Having learned our lesson, I can assure you that from this moment on that we will know the statutes, ramifications, rules, regulations and limitations of Florida corporations and will religiously abide by them all.

We now implore you to allow us to continue as a corporate entity within the State of Florida and to retain our corporate name of RAJA Incorporated.

Our offense, if considered that, causing dissolution was our own ignorance and we now beg you for full reinstatement of our corporation without additional fee.

Enclosed please find our check in the amount of \$165.00, which your representative has advised us would cover our Annual Report Fee of \$61.25 and Corporate Supplemental Fee of \$103.75.

Thank you for your kind consideration and understanding of our explanation concerning this matter. Please advise us of any additional charges, should they be necessary.
