ARTICLES OF INCORPORATION

U.N.I. INTERNATIONAL PUBLISHING GROUP, INC.

ARTICLE I. NAME

The name of this corporation shall be U.N.I. INTERNATIONAL PUBLISHING GROUP, INC.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of filing of these Articles of Incorporation by the Department of State. This corporation's duration shall be perpetual.
