## ARTICLES OF INCORPORATION

OF

### JOHN H. BROWN ENERGY CONSULTANTS, INC.

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

### ARTICLE I

The name of this corporation shall be:

JOHN H. BROWN ENERGY CONSULTANTS, INC.

# ARTICLE II

This corporation shall engage in the operation of acting as consultant in regard to energy needs and methods to improve energy efficiency in the construction or renovation of improvements to real property; and shall do any and all things in connection with the establishment of said corporation, and may engage in any activity or business permitted under the laws of the State of Florida, including entering into contracts of co-partnership or general partnership and acting as surety for the accommodation of third parties.

No contract or other transaction between this corporation and any other corporation, and no act of this corporation, shall in any way be affec if or invalidated by the fact that any of the directors of this corpo tion are pacuniarily or otherwise interested in, or are directors or officers of such other corporation. Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of this corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any officer of such other corporation, or who is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation which will authorize any such contract or transaction with like force and effect as if he were not such director or officers of such other corporation, or not so interested.


