THE UNDERSIGNED, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

The name of the Corporation is Sheridan Dry Cleaners, Inc. and its mailing address is 3337 Sheridan Street, Hollywood, Florida.

ARTICLE II

This Corporation shall have perpetual existence.

ARTICLE III

This Corporation is organized for the purpose of transacting any and all lawful business for which a Corporation may be incorporated in the State of Florida.

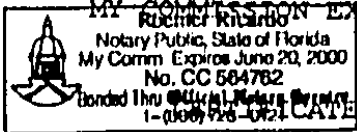
