**ARTICLES OF INCORPORATION OF
MEDICAL CLAIMS SOLUTIONS, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, do hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is Medical Claims Solutions, Inc.

ARTICLE II

The street address of the principal office of the Corporation is 2 Calle Traviesa, Pensacola Beach, Florida 32581.

ARTICLE III

The maximum number of shares this corporation is authorized to issue is 1000, all of which shall be Common Shares. Par value of shares is \$1.00 per share. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. The Corporation elects to have preemptive rights.
