ARTICLE I - NAME

The name of the corporation shall be a professional association and shall be known as Kevin Palley, P.A.

ARTICLE II - DURATION



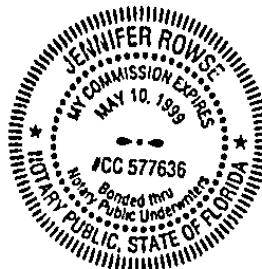
