The aggregate number of shares which the corporation shall have authority to issue is 100, at no par value.


## ARTICLE FIVE

#### ARTICLE EIGHT


The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
