I, the undersigned incorporator, hereby form a corporation under the provisions of Chapter 607, Florida Statutes, and the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be VENICE DECORATORS, INC. The address of the principal office shall be 507 Saltide Way, St. Augustine, Florida 32084 and the mailing address of this corporation shall be the same.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory, or nation.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock.

ARTICLE IV - INCORPORATORS

The names and addresses of the persons who are to serve as the initial officers of this corporation, who shall hold office for the first year of the corporation or until a successor is elected or appointed, are:


