The undersigned subscriber (s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

ARTICLE 1. - NAME

The name of this corporation is:

ARTICLE 11. - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

- (a) To engage in the sales & marketing of all types of wearing apparel & related accessories at both wholesale and retail, domestically & for export, and to engage in any & all other functions, services, and/or activities considered necessary, incidental, proper and/or ancillary, thereto, and to do all other things which may be desirable to achieve the purposes, aforesaid, and to operate a successful business.
- (b) To manufacture, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services of every class, kind and description.
