ARTICLE 1. - NAME

The name of the corporation is CAFYD Enterprises, Inc.



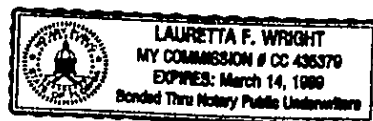
