CORPORATE NAME

The name of this corporation is **AMBIANCE KITCHENS TOO, INC.**

ARTICLE II

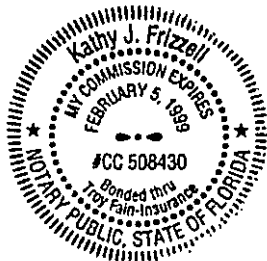


