ARTICLES OF INCORPORATION  
OF  
LORE 'N MORE, INC.

The undersigned incorporator, desiring to form a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of the Corporation is LORE 'N MORE, INC.

Article II

Principal Office and Mailing Address

The principal office of the Corporation is located at 4322 S. Clark Avenue, Tampa, Florida 33611, and its mailing address is 4322 S. Clark Avenue, Tampa, Florida 33611.

ARTICLE III

Duration

This Corporation shall have perpetual existence, commencing with the date of the execution and acknowledgement of these Articles of Incorporation, or if these Articles are filed more than five (5) days after such date, commencing with the filing of these Articles by the Department of State of the State of Florida.

ARTICLE IV

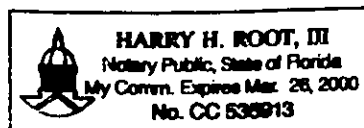
