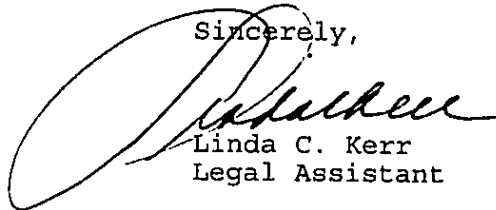

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is ADVANCED CARDIAC INSTITUTE OF BROWARD, INC. and its business mailing address is 420 Lincoln Road, Suite 250, Miami Beach, Florida 33139.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000,000 shares of common stock having no par value.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

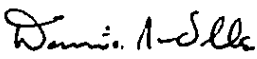
