



**ARTICLES OF INCORPORATION  
OF  
PRODUCTIVE MEDIA, INC.**

The undersigned, acting as incorporator, hereby adopts these Articles of Incorporation and forms a for - profit corporation (the "Corporation") under the laws of the State of Florida, as follows:

**1. NAME**

The name of the Corporation is:

Productive Media, Inc.

The corporation intends to do business as Hispanic Market News.

**2. TERM OF EXISTENCE**

The date when the corporate existence shall commence shall be October 30, 1996, and the Corporation shall have perpetual existence thereafter.

**3. PURPOSE**

The purpose for which the Corporation is organized is to transact any and all business for which a corporation may be incorporated under Florida laws, including the ownership and operation of real property.

**4. CAPITAL STOCK**

The Corporation shall have the authority to issue 100 shares of common stock, in one class only, each with a par value of \$1.00.

**7. INCORPORATOR**


