**ARTICLE I - NAME**

The name of this Corporation is BREWSTER INVESTMENTS, INC. and its address is P.O. Box 2136, Delray Beach, FL 33447-2136.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


#### ARTICLE IX - INCORPORATOR
