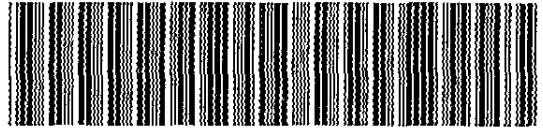




ARTICLE I - NAME
