The name of this corporation is WILL NEEL GOLF ACADEMY, INC.

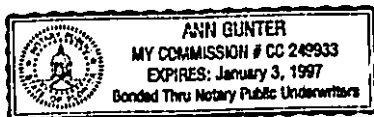
