I, the undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby subscribe to and form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is RASHI SHIPPING, INC.

ARTICLE II

The principal place of business and mailing address of this corporation shall be 7627 Courtney Campbell Causeway, Tampa, Florida 33607. The Directors may from time to time designate such other address and place for the principal office of the corporation as they deem appropriate.

ARTICLE III

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common capital stock, each share having a par value of \$1.00 (one dollar). Authorized common capital stock may be paid for in cash, services or property at a just value to be fixed by the stockholders of the corporation at any regular or special meeting thereof.

ARTICLE V

The amount of capital with which the corporation shall commence business shall be not less than \$500.00 (five hundred dollars).

ARTICLE VI

This corporation shall have a perpetual existence.

ARTICLE VII

The directors of this corporation shall be not less than one (1). This number may be increased or diminished from time to time pursuant to the bylaws adopted by the stockholders of the corporation, but shall never be less than one.
