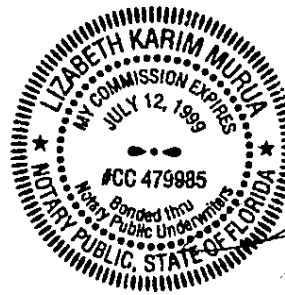



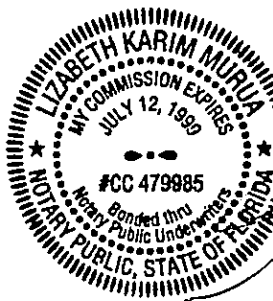
Amendment

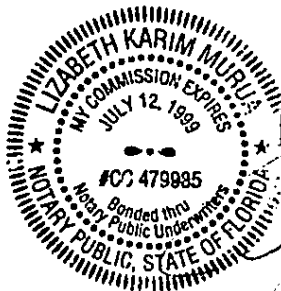
